This work included the largest and longest running cost of insurance litigations in New York, which settled the night before the jury was chosen. He has represented lenders and borrowers in commercial real estate disputes, including assisting one client with obtaining a first-of-its kind preliminary injunction and temporary restraining order challenging a non-judicial UCC foreclosure at the beginning of the COVID pandemic. Mr. Lamberti also extensive appellate experience. He has briefed appeals at the Second Circuit and among several departments of the Appellate Division of New York, and argued several appeals, including successfully obtaining a rare reversal of verdict following a bench trial.
