Mr. Bermann maintains an active pro bono practice. He represented the American Sociological Association as *amicus curiae* in support of same-sex marriage in *United States v. Windsor* (2013) and *Obergefell v. Hodges* (2015), the Supreme Court cases that legalized same-sex marriage in the United States.

Mr. Bermann received his J.D. from Yale Law School and A.B., *magna cum laude*, from Princeton University, where he was elected Class President all four years. He is fluent in French.
